Americot, Inc.is excited to team up with UPI Interline® herbicide to bring this offer to Americot cotton growers who purchase NexGen® XtendFlex® cotton seed varieties along with Interline herbicide in the defined program geography.

QUALIFYING PRODUCTS & INCENTIVE.

Growers who purchase a minimum of 40 UNITS of NexGen XtendFlex cotton seed, and a minimum of 60 GALLONS of Interline herbicide will receive cash rebate as follows:

- Up to \$2.50 per Acre Interline herbicide rebate Incentive can be earned on up to 2 applications of Interline herbicide (total 64 fluid ounces) per acre.
- 1 cotton seed unit of NexGen XtendFlex = 6 acres.
- This is a cash rebate offer paid as a 2 party check to the grower and dealer supplying Interline herbicide, upon satisfaction of all proof of purchase documents. This is not a points or merchandise incentive.

Weed Management RECOMMENDATION.

For optimal weed control, the following weed management program is recommended:

- Apply pre-emergent residual herbicides prior to, or at planting.
- Apply first application of 32-43 fluid ounces/acre of Interline Herbicide to XtendFlex Cotton when weeds are 3-4 inches maximum height. Interline herbicide may be tank mixed with other residual herbicides like Moccasin™ brand S-Metolachlor
- Apply a second application of Interline herbicide 10-14 days later if required.
- Optimum water volume is 15 gallons per acre.
- If weeds exceed recommended height or heavy population, apply Interline @ 43 fl.oz in 20 gal of water and plan sequential application 7 days later.

QUALIFYING PURCHASE DATES.

NexGen XtendFlex cotton seed and Interline herbicide purchases must be made between November 1, 2017 and August 31, 2018.

PROOF OF PURCHASE:

To receive payment under this program, the following proof-of-purchase is required:

- Date Purchased, Number of Units Purchased of qualifying NexGen XtendFlex cotton seed, and Dealer name and address from whom qualifying seed was purchased. We will accept invoice copies or retailer sales reports verifying purchases, or a complete purchase report from Americot, Inc that details the required information for seed purchases.
- Proof of purchase invoices or dealer sales reports for Interline herbicide purchases must contain **date purchased**, **package size purchased**, **volume purchased**, **and name and address of retailer**. Please note bill of ladings are not valid proof of purchase.
